## PLANNING INFORMATION REQUESTS

A planning information request gives you planning information about a specific property.

We can provide:

- A **list** of what planning permits have been granted on a particular site
- A formal response to whether a planning permit would be required for a Use or Development

**Please Note:** This Form is **not** to be used for:

- Applications for Copies of Planning Permits, Endorsed Plans or any Documentation from a closed file. If you wish to request a copy of any of the documents listed above, please follow [this link](#) to submit a Freedom of Information Request through our Governance Team
- Applications for Planning Certificates. Planning Certificates can be applied for through State Governments Website: <https://www.planning.vic.gov.au/guides-and-resources/guides/all-guides/planning-certificates>

## FEES

- List of any Planning Permits previously issued for the site - \$30.00
- Written Request for information – Residential - \$200.00
- Written Request for Information – Commercial/Industrial/Other - \$300.00
